## Woven Vinyl Flooring Care and Cleaning

One of the best ways to keep your new Woven Vinyl Flooring looking good is to hose it off on a weekly basis with clean water. This helps prevent dirt from becoming deeply embedded in the flooring and eliminates the need for more vigorous cleaning. Your new Woven Vinyl flooring does not promote mildew growth; however, mildew may grow on dirt and other foreign substances that are not removed from the flooring. In most environments, a thorough cleaning will be required as soiling dictates. When it's time for light or thorough cleaning, please use the following instructions.

---

### **General or Light Cleaning**

- Brush off loose dirt and hose down flooring.
- Prepare a solution of water and mild soap such as dishwashing liquid or a gentle household cleaner.
- Apply a small amount of water and soap mixture.
- Use a **soft bristle** brush to clean.
- Rinse thoroughly until all soap residue is removed.
- Allow to air dry.
- May require retreatment depending on the soiling level of the fabric.

---

### **Heavy Cleaning for Stubborn Stains and Mildew**

If stubborn stains persist, use a diluted bleach/soap mixture for spot cleaning of mildew. For roof run-off or other similar stains, a strong degreaser may be required.

To clean stubborn stains:

- Prepare a solution of 1 cup bleach and 1/4 cup mild soap per gallon of clean water.
- Apply small amount of bleach & soap mixture.
- Blot stain with a sponge or clean towel.
- Rinse thoroughly to remove all cleaner residue.
- Allow to air dry.

# CORINTHIAN MARINE GLUE DOWN MARINE FLOORING WARRANTY

Corinthian Marine (Corinthian) warrants that this marine flooring will not degrade or fade under normal intended use due to defects in materials or workmanship for a period of five (5) years from the date of the original purchase of the carpeting.

Corinthian agrees to replace the defective flooring with an equivalent or substantially similar grade, either for the affected area or the entire flooring surface containing the affected area, as determined by Corinthian's sole discretion.

This warranty does not apply if: (a) the flooring has been subject to abuse, misuse, accident, alteration, neglect or the application of improper or solvent based cleaning agents or procedure; or (b) the flooring has been exposed to abnormal and extreme conditions, artificial or environmental, including light amplification from a reflective surface (c) tears, burns, pulls, cuts, pilling, or shredding. Additionally, this warranty extends only to the original purchaser and to no other persons or entities. This warranty is limited solely to the replacement of the defective flooring with a like or substantially similar grade of carpet or flooring and specifically excludes any labor charge to remove the old flooring, installation charges to install new flooring, or any other miscellaneous labor charges.

Replacement of marine flooring will be prorated based on the following formula: Months of Use/60 Months = % Adjustment.
